

Coconut Pineapple Pie

Ingredients:

- 3 eggs slightly beaten
- 6 Tbsps Butter softened
- $1\frac{1}{2}$ cups sugar
- 3 Tbsps flour
- 1 cup crushed pineapple drained
- 1 cup coconut flakes
- (1) 9inch deep dish pie crust

Directions:

- 1. Mix first four ingredients until well blended. (eggs, butter, sugar, flour)
- 2. Stir in pineapple and coconut
- 3. Pour into pie crust
- 4. Bake at 350 degrees for 50 to 55 minutes or until top is golden brown.
- 5. Cool on rack then refrigerate overnight.


