2 tsp baking powder 2 ½ c wild blueberries





he Department of Veterans Affairs (VA) announced it will re-adjudicate claims for Veterans who served in the offshore waters of the Republic of Vietnam during the Vietnam War.



This review is part of the Veterans Benefits Administration's implementation of the November 5, 2020, U.S. District Court of the Northern District of California decision to re-adjudicate previously denied claims as applied in Nehmer vs. U.S. Department of Veterans Affairs.

Veterans who were previously denied service connection for an herbicide related presumptive condition due to lack of in-country Vietnam service will automatically have their claims readjudicated.

Re-adjudication means VA will review the evidence of record and provide replacement decisions in the cases of Veterans who were previously denied service connection for one or more herbicide related conditions on the basis that military service was not performed on the landmass of the Republic of Vietnam or on its inland waterways. This review will also apply to eligible survivors of deceased Vietnam era Veterans. VA is dedicated to ensuring all Veterans receive the benefits they have earned.

VA ensures that we have the proper resources in place to meet the needs of the Veteran community. Eligible survivors of deceased Veterans may also benefit from the policy and may be eligible for benefits based on the Veterans' service.



PARK ROYALE GOVERNING DOCUMENT

PROSPECTUS

To pon acquiring a property in Park Royale Mobile Home Park (MHP) you should be given a copy of prospectus including the lease, site document and rules and regulations. If you are purchasing from an individual either by a direct sale or via a real-estate broker, they ought to give you this documentation. Upon approval of your worthiness via a security background check the park management will complete the lease and also confirm that you have the governing documents. If you purchase the property from the park management's real-estate broker, they should provide you with a package of all these documents along with the sale and tax documents. If you have lost the prospectus and its attachments you can download the most current documents from the DBPR website at:

(http://mygovhelp.info/FLDBPR/_cs/supporthome.aspx).

The amount of your monthly land lease amount will be included in the annual lease document along with the method of increasing the monthly rent in January of the following years. There are generally three methods of rent increases. The basis for the changes in the annual lease amount computation:

- 1. base costs: changes for water, sewer, waste, maintenance, management, property taxes, major repairs, state and local government actions, and utility company;
- 2. prevailing market conditions: rents and charges paid by comparable parks in the same general vicinity;
- 3. prevailing economic conditions: factors considered by a prudent businessman: replacement costs; interest rates; alternative investment opportunities; Consumer Price Index (CPI); rate of return on owner equity (stock dividends); other economic factors.

Owners are to be notified 90 days in advance of an increase in the Lot Rental Amount. Depending on how you compute 90 days or 3 months you should expect to receive a notice of change on or about October 1st.

Section 031 of Florida Statute 723 the Florida Mobile Home Act, states that rent can only be increased one time per year at the date of expiration of the term of the lot rental agreement. All rents between similar situated tenants' properties will be comparable. (723.031(5)). The purchaser of a mobile home, has the right to assume the unexpired rental agreement that is in effect at the time of purchase from the seller. (723.059(3))

In review of the past annual changes in rent, my research suggests that the last time the rent did not increase was in 2007. At that time the charge for water usage was removed from the monthly lot lease base rent and became separately billable. It appears that the monthly amount was reduce by \$32 dollars with the issuance of a separate water usage billing. There was more to that agreement and as that information becomes available, we will share it with you.


