

y apologies to everyone on the date of the next HOA meeting. I put in the wrong date, it should have said "Monday November 15th" instead of the 8th. I am sorry for the confusion. There will also be a notice on the bulletin board in the clubhouse with the correct date.

For the combining of the HOA and the Community Club, if passed, there will be only one organization handling all social and business activities. A new committee would be formed to coordinate all social functions (dances, dinners, parties, etc.).

As far as dues are concerned, there will be one dues for the HOA. This would be split and deposited in two bank accounts (legal fund and social fund). I envision this to be less per household than the combination of the two present dues.

The meetings would be held under the same format that both organizations currently use, i.e. call to order, reading of minutes, treasurer's report, old business, new business, adjournment. There will not be "Community Club business" and "HOA business", just "new" and "old" business. The length of the meetings should be approximately the same length as they presently are for the Community Club meetings with the exception of the November meeting when rent increases are discussed. Voting would change slightly in that there would be one vote per household versus one vote per individual. A couple in the same home would cast one vote as would a single person in a home would cast one vote.

Some benefits to the merger would be in regards to the annual filing fee of incorporation with the state, paying for a single insurance policy instead of two, confusion for new residents as to which organization to go to with questions or complaints.

I am sure that I have not covered everything here, but these items are probably the most important. If you see me around the park, feel free to stop me and ask any questions.

CHEF'S CORNER:

Peanut Chicken Sheet-Pan Dinner

Ingredients

- 1/4 cup creamy peanut butter
- $\frac{1}{4}$ cup water
- 2 tablespoons soy sauce
- 1 tablespoon apple cider vinegar
- 2 teaspoons grated fresh gingerroot
- 1 lb boneless skinless chicken tenders
- 3 cups fresh broccoli florets



Fresh lime, chopped peanuts, diagonally sliced green onions and crushed red pepper flakes, if desired

PREPERATION

Heat oven to 400°F. Spray 15x10x1-inch pan with cooking spray. In large bowl, mix peanut butter, water, soy sauce, vinegar andgingerroot using whisk.

Add chicken and broccoli to bowl; toss to coat. Spoon chicken mixture evenly onto sheet pan. Bake 20 to 25 minutes or until chicken is tender and no longer pink in center and broccoli is crisp-tender. Stir gently before serving. Squeeze lime over chicken and broccoli. Garnish servings with remaining ingredients.

CARMEL STICKY BUNS

Ingredients

Topping 1/4 cup margarine or butter, melted 1/4 cup firmly packed brown sugar 2 tablespoons light corn syrup 1/4 cup chopped pecans Buns 1 tablespoon sugar 1/2 teaspoon cinnamon



1 can (12 oz) refrigerated Pillsbury[™] Flaky Layers Buttermilk Biscuits (10 Count)

PREPERATION

Heat oven to 375°F. Grease 12 muffin cups. In small bowl, combine all topping ingredients; mix well. Spoon scant tablespoon topping into each greased muffin cup. In plastic bag, combine sugar and cinnamon; mix well. Separate dough into 10 biscuits. Cut each biscuit into 6 pieces. Shake pieces in sugar mixture. Place 5 pieces of dough in each muffin cup. Place pan on foil or cookie sheet during baking to guard against spills. Bake at 375°F. for 15 to 20 minutes or until golden brown. Cool 1 minute. Invert onto waxed paper. Serve warm.

BOUNTYFUL SUMMER SALAD

INGREDIENTS

head Lettuce (your choice)
 lg Beef Steak Tomatoes*
 stalks Celery
 hard boiled Eggs
 sweet peppers (red, green orange)
 or 6 spring onions(scallions)
 green Olives



4 oz block Cheddar Cheese
½ cup dried onion pcs.
½ cup dry chow mein noodles

1 cup flavored croutons
½ cup Dressing (Raspberry, Italian etc)
(* substitute Cherry Tomatoes if so desired)

PREPERATION

(Soak all veggies in cold water for 10 minutes to remove dirt/chemicals) Using a large salad bowl, core and chop the lettuce. Slice tomatoes and quarter the slices or add 1 cup of Cherry Tomatoes. Cut celery in $\frac{1}{2}$ inch pcs. Chop the hard boiled eggs. Cut the different color peppers into small bite size pcs. Cut both ends from spring onions and dice into $\frac{1}{2}$ inch pcs. Cut the block cheese in to $\frac{1}{4}$ pcs. Toss all of these ingredients in the bowl, including the olives. Either pour on the dressing and toss or serve it on the side. Sprinkle the dried onion pcs., noodles and croutons on top and serve.




