We are noticing a lot of incomplete address return to senders (even our bills we pay). Apparently it has to say OFFICE because if Scotty (our wonderful mailman) takes a day off it's getting sent back to sender and causing a lot of delay and confusion. **This is something new apparently**

PLEASE do not feed Florida Wildlife - They can fend for themselves and if they rely heavy on residents feeding them they become Prey, it truly is unfair to them. Not only that but it is against the Pinellas County Laws to feed Florida Wildlife. We are being specific about the ducks this month. The duck families we currently have at La Plaza are known as the Muscovy duck. They are a NON NATIVE species to Florida and are not protected and considered a nuisance duck. They cause property damage, can be aggressive to humans and other Florida Native wildlife and their droppings carry disease that will not only harm native birds but could cause our pond to become disease ridden. I have hung up information about these nuisance ducks in the clubhouse, if you would like to read what the County Wildlife Service's sent me. These ducks are such a nuisance in the county they want them trapped and disposed of, not relocate them. They continue to breed and the colony here is getting extremely large. Things you can do to help so they will leave our park, DO NOT FEED OR GIVE WATER TO THEM, chase them off your lot, haze them with a garden hose. We appreciate any efforts you put forth in helping us make our park beautiful again with native Florida wildlife, that won't come in the park due to the amount of Muscovy ducks.
