

**ater and Sewer:** Pinellas County held a town hall to discuss the sewer project. Information on the presentation was sent out in an email blast. If you have any questions, please contact Duncan Brown at lsrdirector6@gmail.com

-+**Mueller Lawsuit:** LSR has been notified that we have been dropped from the Mueller lawsuit.

#### **Pool/Well Water:**

• The park is continuing to use county water to fill the pool instead of purified well water. This is being done to determine if the cost of the potable water is offset by the need for increased chemicals for the well water and the repair of the well water system. To date, the average use to fill the pool due to evaporation is less than 600 gallons per day.

**Water Usage:** Water usage in the park is up about 10% over last year. This is due to the use of county water being used to fill the pool for evaporation, and the increase of full-time people in the park.

#### Maintenance:

- The support posts by the pool have all been replaced.
- A new window air conditioner was installed in the library.
- The chandeliers in the hall are being repainted to enhance the look of the hall. This should be completed by the end of June.
- Watkins pond requires a new pump, wiring, and controller. The cost is approximately \$5400.
- The second pump for the well system was repaired and installed at a cost of \$2750.
- Because of the breakage in of the new light switches in the pool bathrooms, the switches are being replaced with on/off switches as we had before.
- Two well systems leaks were found; one behind a resident's home used for personal use, and a second leak by the spa shower. The spa shower leak will be repaired in July.

# Remember: Residents should shut off all water, potable and well water, when leaving the park for any extended period.

**Wyatt Property:** The Wyatt property auction has been rescheduled for July 13 at 10:00 am. An email blast with all the pertinent information was sent to residents.

**Energy Use and Conservation:** The park has six electrical meters. The highest electrical usage for LSR is the recreation hall, followed by the pool, and then the streetlights. The board



is evaluating a proposal to replace all streetlights with LEDs. This would reduce the electricity use of the lights significantly. Current estimates of savings are \$2000 per year. Duke energy has agreed to replace the lights at no cost to the park with the agreement that the park contracts Duke for a period of ten (10) years for the lights. The savings could increase as the electric rates increase over the ten-year period.

In addition to the replacement of the streetlights, the board is reinvigorating its investigation into the use of solar power. A solar power committee has been formed and will look at options for the park, focused on the best advantage to the park.

**Call Blasts:** Communications with the residents is crucial for the effective operation of the park and for the board to be effective. Some residents do not receive emails, do not look at the bulletin boards, do not attend coffee, do not read the monthly reports, nor look at the website for information on upcoming events or information regarding the park. The board is looking into a "call blast" service that would call all residents with information now supplied in email blasts. This would require residents to accept these calls and not block the information.

Hall Reservation Form: There is a new hall reservation form that includes a checklist for the user to fill out and return to the office after any event is held in the hall.

**Website:** Kathy McQuiston-O'Dell has been making changes to the LSR website to make it easier to use and more beneficial to the shareholders. Kathy will update the residents on many of the updates at the upcoming board meeting.

#### **Financial Status:**

- Financial information for June is posted in the hall.
- The park continues to experience infrastructure maintenance cost increases. The latest cost to the well system, Watkins pond, and the front fountain were unplanned at the beginning of the year.

**Board Meeting:** The Board meeting scheduled for June was postponed due to equipment issues related to a power surge. A Board Meeting is scheduled to be held in the hall and via Zoom on July 17 at 10:30 am after coffee.

**Town Hall:** A town hall will be held in the hall on July 10 at 10:30 am. It will be broadcast via Zoom.

# **Civic Holiday in Canada**

- 2. Special Needs How to register for "Special Needs Assistance" and a list of special needs shelters.
- 3. Sand Bags Info on obtaining sand bags for residents not required to evacuate
- 4. Emergency Road Closures Road closures within Pinellas County
- **5.** Know Your Zone Evacuation zones all mobile home parks are under mandatory evacuation during any evacuation order.
- 6. During and After a Storm Information on cleanup after the storm.
- 7. Disaster Assistance Information on insurance claims and FEMA

It is very important that <u>any resident requiring assistance for evacuation, register on the</u> <u>"Special Needs" site</u>. It is the only way that the County will be aware of their needs whether it is medical, mobility, or transportation, etc.

Our in-house LSR "Disaster Relief" form is to supply basic info to assist EMS and First Responders to perform search and rescue within the park during a severe weather event.

# Are you a chronic collector?

o you have too much useless stuff on your desk? If your work area is messy from hoarding, maybe you can blame it on the primitive part of your brain.

Cows and rats hoard, as well as humans. In fact, about 70 species in all hoard things. Usually it's food, but it can be something totally useless to the hoarder. The act of hoarding involves primitive as well as the higher functions of brain structure. Steven W. Anderson, a neurologist and researcher, recently looked at 86 people who had lesions on various and well-defined areas of the brain. He found that one reason for hoarding was damage to the right mesial frontal region, the very primitive region of the brain that houses the collecting urge lost its guidance.
