

n January 1st, a walking group was started by Nancy Erhardt. The goal is to get residents of IITS walking more, which is great for our health. Members sign on for one of two groups: 5,000 steps/day or 10,000 steps/ day. On the last Wednesday of the month the group meets at the clubhouse and walks to Pete & Shorty's for dinner, drinks and laughs. Each person keeps track of their steps and turns them in at the dinner. Prizes are given. In January,



Donna Stewart walked 218,523 steps to lead the 5,000-step group and Laurel Ross walked 475,362 steps in the10,000 step group. February had several people increasing their steps over the prior month. Scott Schewe walked 53,551 more steps in February, leading the 5,000-step group with 256,047 steps. Elaine Ranck walked 175,441 more steps than she did in January, but her total was outdone by Molly Johnson who walked 556,036 steps!

- oronavirus Disease 2019 (COVID-19) How to Protect Yourself from Coronavirus Know How it Spreads
 - There is currently no vaccine to prevent coronavirus disease 2019 (COVID-19).
 - The best way to prevent illness is to avoid being exposed to this virus.
 - The virus is thought to spread mainly from person-to-person. o Between people who are in close contact with one another (within about 6 feet). o Through respiratory droplets produced when an infected person coughs or sneezes.
 - These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

Take steps to protect yourself

Clean your hands often

- Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose, and mouth with unwashed hands.

Avoid close contact

- Avoid close contact with people who are sick
- Put **distance between yourself and other people** if COVID-19 is spreading in your community. This is especially important for <u>people who are at higher risk of getting very sick</u>.

Take steps to protect others

Stay home if you're sick

- Stay home if you are sick, except to get medical care. Learn what to do if you are sick.
- Cover coughs and sneezes
- Cover your mouth and nose with a tissue when you cough or sneeze or use the inside of your elbow.

• Throw used tissues in the trash.

• Immediately **wash your hands** with soap and water for at least 20 seconds. If soap and water are not readily available, clean your hands with a hand sanitizer that contains at least 60% alcohol.

Wear a facemask if you are sick

- If you are sick: You should wear a facemask when you are around other people (e.g., sharing a room or vehicle) and before you enter a healthcare provider's office. If you are not able to wear a facemask (for example, because it causes trouble breathing), then you should do your best to cover your coughs and sneezes, and people who are caring for you should wear a facemask if they enter your room. Learn what to do if you are sick.
- If you are NOT sick: You do not need to wear a facemask unless you are caring for someone who is sick (and they are not able to wear a facemask). Facemasks may be in short supply and they should be saved for caregivers.

Clean and disinfect

- Clean AND disinfect <u>frequently touched surfaces</u> daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks.
- If surfaces are dirty, clean them: Use detergent or soap and water prior to disinfection.

To disinfect:

Most common EPA-registered household disinfectants will work. Use disinfectants appropriate for the surface.

Options include:

• Diluting your household bleach.

To make a bleach solution, mix:

o 5 tablespoons (1/3rd cup) bleach per gallon of water OR

o 4 teaspoons bleach per quart of water

Follow manufacturer's instructions for application and proper ventilation. Check to ensure the product is not past its expiration date. Never mix household bleach with ammonia or any other cleanser. Unexpired household bleach will be effective against coronaviruses when properly diluted.

• Alcohol solutions.

Ensure solution has at least 70% alcohol.

• Other common EPA-registered household disinfectants.

Products with <u>EPA-approved emerging viral pathogens</u> claims are expected to be effective against COVID-19 based on data for harder to kill viruses. Follow the manufacturer's instructions for all cleaning and disinfection products (e.g., concentration, application method and contact time, etc.).

You can borrow tools from the Safety Harbor Library (and I think other Pinellas County Libraries). All you need is a library card. For the snowbirds, you just have to provide proof of residence to get library

card. That could be a utility bill, your home ownership papers or car registration if you happen to have licensed your car in Florida. I'm not sure if there would be an issue with our Canadian friends. To see if they have what you need, you don't need a library card. Search for the library site and then click on the Tool Library symbol.

If you put your lot number and street name in your GPS, you will get directions right to your house? Tallahassee, Fla. — Today, in the state's ongoing efforts to provide transparency and clarity regarding COVID-19, the Florida Department of Health announced the launch of a new COVID-19 Case Dashboard. To keep Florida residents and visitors safe, informed and aware about the status of the virus, this dashboard will be updated twice daily.

As of noon, there are 155 total** Florida cases:

- This includes 19 additional positive COVID-19 cases (14 Florida residents and 5 non-Florida residents) were reported to the Florida Department of Health.
- There are currently 137 positive cases in Florida Residents and 18 positive cases in non-Florida residents.

Florida recently partnered with private laboratories around the state to expand COVID-19 laboratory testing capacity. This partnership will increase the number of tests conducted each day and ensure Floridians receive the critical health information they need in a timely manner.


Expansion to private laboratories changes the COVID-19 testing landscape in Florida. Private laboratories will run tests as they receive swab samples from practitioners. Testing and reporting times will vary among commercial and DOH laboratories. Demographic information may be updated during investigations.


