

# **DID YOU KNOW!**

- **NOON HEAT**: Located north of Earth's equator at 23.5 degrees north, the Tropic of Cancer is one of the five major degree measures that divide the Earth. In the northern hemisphere, it is the point at which the sun's rays are directly overhead at noon on the summer solstice, June 21.
- **POWER PLANT:** Opened in 1984, the Itaipu Dam is an enormous structure that supplies electricity for Brazil and Paraguay. Located on the border of these two countries on the Parana River, the dam is almost five miles long.
- **FORTIFIED CITY:** Quebec City is the capital of the province of Quebec (Canada). Predominantly French-speaking today, it is also known as Ville de Quebec. The part of the city called Old Quebec still has fortified walls.
- LONG RAILROAD: In 1862, President Abraham Lincoln signed the Pacific Railway Act. This ensured that the government would help fund the Transcontinental Railroad, making travel easier across the vast North American continent.





The are looking for <u>volunteers to run for The Board of Directors</u> and to help with planning and running events at the clubhouse.

This month we continue to describe Section 3 of the HOA BY-LAWS with the requirements of acquiring the park should the opportunity arise.

What is the purpose of the HOA?

The BY-LAWS state the following <u>PURPOSE of the HOA</u>.

- 1. To act for the benefit of the Association members in dealing with the owners and operators of La Plaza Mobile Home Park in Largo, Florida (the "Park"), including but not limited to operating through the Rent Committee to address proposed changes in rent charged or services and amenities to be provided by the Park.
- 2. To facilitate the organization and implementation of social activities to enhance the



quality of life of Association members and renters in the Park.

3. Should the opportunity arise and the members approve, to negotiate for, acquire and operate the Park on behalf of mobile home owners. The Association shall also have the power to convert the Park, if acquired, to condominium, cooperative or subdivision form of ownership, or another type of ownership.

# What do we get from having an HOA?

The Florida Statue Chapter 723 Law provides several important things to HOA's. The first right of refusal for the HOA to purchase the park is one of the things we are entitled to should the Park Owner decide to sell the Mobile Home Park or change the property use. Some of the steps to a task of this nature follow.

# Steps that are required to accomplish first right of refusal:

- 1. When we organized as a Florida Not-for-Profit Corporation we filed this right with Pinellas Circuit Court.
- 2. The court filing was provided to Wilder LLC per law by certified mail from our attorney.
- 3. In order to execute this first right of refusal it requires a vote of all homeowners in the park.
- 4. Once the approval of homeowners is received, the HOA would change the organizational structure to conform more to a Resident Owned Community with share values by dividing the purchase price by the number of homes.
- 5. Homeowners would have to decide either to purchase a share of the Resident Owned Park or continue to lease the land where their home sits from the newly formed Resident Owned Association.
- 6. Financing would be required from a financial institution for the units in the park where homeowners wanted to continue to leasing the land and not purchase a share of the community.
- 7. There would be Board of Directors of the Association who would most likely hire a management firm to run the Resident Owned Park at the boards direction.
- 8. Homeowners who bought shares would pay lesser monthly fees than those who choose to continue to rent.

These are just some of the things that would be required to convert this Rental Park into a Resident Owned Park, but this is not by any measure a complete list. The above process is very important because Florida Law provides very little protection for mobile home owners. Most of our homes are not new enough to qualify for relocation. That leaves most of us with only the abandonment payment option of \$1,375 for a single wide and \$2,750 for double wide mobile homes. The state trust fund comes from a portion of our annual registration fees that we pay the state each year and some contribution of the park owner who is changing the land use of the mobile home park to something different. If you are of the mind that this type of thing can't happen, I direct you to the southwest corner of Belcher and Gulf to Bay. This property was once a mobile home park and we have a owner here in La Plaza MHP that



lived at that property.

This is another important reason for having an HOA along with the statutory meeting requirement we discussed in the July

La Plaza Ledger.

It is also a big reason that all homeowners should join, volunteer and support the La Plaza HOA and the state organization, the FMO.



Have you purchased or rented a residence in Florida and moved in? (Purchasers of property in this MHP are not eligible for Homestead Exemption benefits because you don't own the land under your mobile.)

Have you verified with a Florida attorney that your estate planning documents (Will, POA, and other legal documents), are compatible with Florida law?

Have you declared FL to be your place of residence in all forms that require recital of residence, such as Social Security, Administration papers, passports, contracts, deeds, leases, credit cards, etc.?

Have you set up Fl banking and investment arrangements here?

Have all arranged for all income sources and direct deposits be sent to FL financial institutions. Have you consulted with a physician in FL and had your medical records sent to the FL doctor? Do you avoid spending significant amounts of time in your former state of residence?

Do you file Federal Income Tax Returns using your FL address and mail them to the IRS in Atlanta, GA.
